



**Hawaii Republican Party  
Data Center, Mailchimp Email Lists, & gophawaii.com Email Accounts  
Confidentiality Agreement Form**

In consideration for and as a condition to Hawaii Republican Party's furnishing the use of data on any platform, including GOP Data Center, mailchimp email lists, and @gophawaii.com email accounts the recipient of information ("the Recipient") acknowledges the confidential nature of the Confidential Information (as defined below) and agrees to every restriction and obligation in this agreement ("the Agreement").

THIS AGREEMENT is made by and between the Hawaii Republican Party State Committee and the Republican Entity of (CIRCLE ONE) Precinct Chair, District Chair, County Chair, Standing Committee Chair, State Party Leader, Candidate / Campaign hereinafter referred to as the parties.

WHEREAS, the Recipient signee desires to utilize and obtain information from the electronic database and voter information retrieval system known as "GOP Data Center", and the State Party has been authorized by the Republican National Committee to issue access privileges, and impose limitations and requirements on the same in order to maintain the integrity of GOP Data Center and the valuable, confidential, and sensitive information contained therein; and

WHEREAS, the Recipient signee desires to utilize and obtain information from the mailchimp database, and the State Party is authorized to and impose limitations and requirements on the same in order to maintain the integrity of our email lists and the valuable, confidential, and sensitive information contained therein; and

WHEREAS, the parties hereto wish to place all the terms and conditions of their agreement in writing;

NOW, THEREFORE, in consideration of the mutual promises and undertakings stated in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. As used in this Agreement, "Confidential Information" means and includes any and all information obtained from the GOP Data Center and mailchimp email lists.
2. The Recipient agrees that the Confidential Information will be kept confidential by the Recipient and by directors, officers, members within the Recipient's own organization (collectively referred to as "Affiliates"), except with prior written permission, as required by law, or as expressly otherwise permitted by the terms of this Agreement.
3. Recipient agrees that neither they nor any of their directors, officers, employees, consultants, or agents will disclose, rent, lease, sell or enter into joint ownership agreements concerning any list(s), information, updates, or enhancement(s) of the Hawaii Republican Party's data system in any form, nor will they retain or duplicate information gained from the Hawaii Republican Party's data system whatsoever.

4. The Recipient agrees to limit their use of the voter information contained in GOP Data Center, mailchimp email lists, and @gophawaii.com email accounts to political purposes only, and that under no circumstances will this information be used for commercial purposes. The Republican Entity and/or Campaign Manager and Campaign Manager's Designee each further agree that they will not permit the use or copying of the voter information contained in GOP Data Center, or mailchimp email lists, or @gophawaii.com email accounts by any person not working under the direction of the Republican National Committee, GOP Data Center or the State Party.
5. It is understood that the Recipient may disclose Confidential Information to only those of the Recipient's Affiliates who (i) have a need to know, and (ii) are informed by the Recipient of the confidential nature of the Confidential Information and the obligations of this Agreement. The Recipient also agrees to be responsible for enforcing the terms of this agreement as to the Recipient's Affiliates.
6. The Recipient agrees that data will be used only for Republican candidates in the state of Hawaii, within their region according to their access level. The Recipient shall not be an active volunteer or employee for a Democrat in any elected position or race. Violation of this condition shall result in immediate denial of access to GOP Data Center, mailchimp email lists, and @gophawaii.com email accounts, or any other platform in use by the Hawaii Republican Party, and a lifetime ban on their use.
7. If the Recipient or any of the Recipient's Affiliates become legally compelled to make a disclosure otherwise prohibited by this Agreement, the Recipient or Affiliate will provide the Hawaii Republican Party with prompt notice of such request.
8. This Agreement states the entire agreement between the parties concerning the disclosure of Confidential Information. Any addition or modification to this Agreement must be made in writing and signed by the parties.
9. If any of the provisions of this Agreement are found to be unenforceable, the remainder shall be enforced as fully as possible and the unenforceable provision(s) shall be deemed modified to the limited extent required to permit enforcement of the Agreement as a whole.

**WHEREFORE, the Recipient acknowledges that they have read and understand this agreement and voluntarily accept the duties and obligations set forth herein.**
